BMCC Items.

A letter from P. Lane-Gonzales reported that

- **Dump at bottom of Zigzag** is still to be assessed and there is no time frame at present.
- **6.2 Mt. Wilson Road washaway** and leaf litter build up. This will be done when the grader is in the area late 2011/early 2012. After grading the road will be bitumined

- **6.3** Eucalypt saplings on the vertical embankment of the Zigzag. Council questions whether MWPA reflects the feeling of the community in this matter.
- P. Lane-Gonzales has accepted an invitation to meet with R. Beattie with Council's urban planner, S. Bell. The agreed date will be rescheduled. Libby Raines will also attend.
- **6.4 Founders Corner toilets.** Water is not running, the vent is broken and the gutter is damaged. R. Beattie will request repairs from Council.

7. GENERAL BUSINESS

- **7.1 Remembrance Day Service.** Brian Abrahams was thanked for the organisation of this service. It was agreed that the day was very good. It was agreed a letter of thanks be sent to Alison Halliday for her excellent talk. There may be difficulties for the 2012 service as Rev. J. Gaunt will be unavailable due to his Sunday Church commitments and C. Carey may be unavailable as he will have completed school by then.
- **7.2 Marcus Clark Reserve.** There is a leaning tree needing attention and the reserve needs a tidy up. This is on Alan Gunn's list.
- **7.3 Website.** A report from G. Tribe was tabled, detailing progress and accounting for stage 2 upgrade.
- **7.4 Christmas party.** The Historical Society's request that the occasion be used for a low key launch for the book on Fred Mann's pottery was approved. Committee members are asked to bring a plate of finger food. Bill Ryan will purchase wine, Moira Green soft drinks and beer. The hall will be set up Friday afternoon at 4.00p.m. Kim Gow agreed to open the hall on Saturday prior to the party.
- **7.5 Great Gatsby filming.** It was decided that a letter be sent to BMCC requesting that the money received from the film company for the hire of Silva Plana be spent on the village to compensate residents for the inconvenience experienced.
- **7.6 Postal Service.** R. Beattie reported that he discussed the parcel delivery issue with someone in authority. It was suggested that if everyone had large boxes, the sorting problem could be eliminated. Bill Ryan will pursue the possibility of having a number of large boxes constructed and organising the installation with the intention of selling them to villages. However, it was decided that there was no guarantee that this would help delivery unless the postman's contract was altered.
- **7.7 Tree Trimming.** The tree in Waterfall Road has been trimmed up by P. Raines, also a number in The Avenue outside the church. M. Fink had trimmed the oaks in Stephen Lane. It was suggested that Tim Gow may be available to do some work for MWPA.
